This Third Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Lake County Office of Education, hereinafter referred to as "Contractor," collectively referred to as the "parties."

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated September 1, 2021 under which contractor will provide school-based specialized mental health services to the residents of Lake County as part of the Mental Health Student Services Act (MHSSA) grant funding through the Mental Health Services Oversight and Accountability Commission (MHSOAC); and

WHEREAS, this Agreement was Amended a first time on January 25, 2022 to reflect updated staffing and the associated budget; and

WHEREAS, this Agreement was Amended a second time on May 9, 2023 to reflect an updated budget; and

WHEREAS, the parties now desire to amend the Agreement a third time to modify Exhibit B, "**Fiscal Provisions**," of the Agreement to reflect necessary program and budget changes approved by the MHSOAC.

NOW, THEREFORE, the parties hereto agree to the following Amendment to the Agreement:

Exhibit "B," Section 3, "Payment Terms" is hereby amended to the state the following:

3. <u>PAYMENT TERMS.</u> County shall provide Seventy-One Thousand, Eight Hundred Thirty-Five Dollars and Eighty-Three Cents \$71,835.83 in funds in Grant Year One (1), Four Hundred Six Thousand, One Hundred Twenty-Two Dollars \$406,122 in funds in Grant Year Two (2), and Eight Hundred Fifty-Nine Thousand, Three Hundred Nine Dollars \$859,309 in Grant Year Three (3) received from the Mental Health Student Services Act grant for a total maximum payable of **One Million, Three Hundred Thirty-Seven Thousand, Two Hundred Sixty-Six Dollars and Eighty-Three Cents (\$1,337,266.83).**
