

**Amendment No. 2 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND NORTH VALLEY BEHAVIORAL HEALTH, LLC. FOR ACUTE
INPATIENT PSYCHIATRIC HOSPITAL SERVICES AND
PROFESSIONAL SERVICES ASSOCIATED WITH ACUTE INPATIENT
PSYCHIATRIC HOSPITALIZATION FOR FISCAL YEAR 2023-24**

This Amendment No. 2 to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and North Valley Behavioral Health, LLC . hereinafter referred to as “Contractor,” collectively referred to as the “parties.”

RECITALS

WHEREAS, the County entered into an Agreement with Contractor effective July 1, 2023, and;

WHEREAS, the Agreement was amended on February 6, 2024 to increase the contract maximum by \$350,000 for a new contract maximum of \$750,000; and

WHEREAS, utilization of services provided by Contractor exceeded projections, and;

WHEREAS, the parties now desire to amend the Agreement a second time to increase the total compensation payable under the Agreement by \$600,000.00 for a new contract maximum of \$1,350,000.00 and must amend item three, “Compensation,” to reflect this change.

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, “**Scope of Services.**” **Compensation to Contractor shall not exceed One Million, Three Hundred Fifty Thousand Dollars (\$1,350,000.00).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled, “**Fiscal Provisions,**” attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.
