Re: Amendment Request

Dear Ms. Deligiannis,

This Proposed Amendment is in reference to the Agreement for Professional Services for Appraisal and Acquisition Services for the Middle Creek Flood Damage Reduction and Ecosystem Restoration Project ("Agreement") dated December 1, 2020, and subsequent Amendment No. 1 dated August 17, 2021, by and between the Lake County Watershed Protection District ("District"), and Monument, Inc. ("Monument"). This Agreement and Amendment approved Monument's original Proposal dated November 2, 2020 ("Proposal") to provide appraisal and acquisition services for the Project, and subsequent Proposal Amendment dated July 30, 2021.

There is roughly \$102,000 remaining budget to close out the remaining activities outlined in the original scope and Amendment 1. The remaining effort includes continued negotiations and escrow on 14 parcels.

In addition to the ongoing efforts, District staff identified additional efforts necessary to complete the project. Those tasks are itemized below:

- Perform up to an additional seven (7) residential relocations within Project area. (6-month duration)
- Perform up to an additional ten (10) acquisitions within Project area. (6-month duration, 12 contacts)
- Deliver up to an additional ten (10) appraisal reports.
- Deliver up to six (6) appraisal updates as requested by DWR.
- Provide additional as-needed Project Management and Support services for a 36-month period commencing upon full execution of Amendment No. 2 to the original Agreement, including, but not limited to:
 - Project planning and monitoring
 - Escrow and title coordination
 - o DWR coordination
 - Schedule development and monitoring
 - o Process development and monitoring
 - Property owner contact and pre-acquisition engagement
 - Coordination with District Staff and Project Committee

UPDATED COST PROPOSAL

Monument will complete the original scope of work as detailed in the Agreement, along with the additional tasks detailed above. Our original contract was for \$187,400. Amendment No. 1 added \$82,500, for an updated total contract amount of \$269,900. Based on the above discussions, this Amendment No. 2 will increase the total contract amount by an additional \$229,800, as detailed below. The new total contract amount will be \$499,700.
