

**Amendment No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND CALIFORNIA PSYCHIATRIC TRANSITIONS FOR ACUTE
INPATIENT PSYCHIATRIC HOSPITAL SERVICES, INPATIENT
COMPETENCY RESTORATION SERVICES, AND PROFESSIONAL
SERVICES ASSOCIATED WITH ACUTE INPATIENT PSYCHIATRIC
HOSPITALIZATION FOR FISCAL YEAR 2023-24**

This Amendment No. 1 to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and California Psychiatric Transitions referred to as “Contractor,” collectively referred to as the “parties.”

RECITALS

WHEREAS, the County entered into an Agreement with Contractor effective July 1, 2023, and;

WHEREAS, utilization of services provided by Contractor exceeded projections, and;

WHEREAS, the parties now desire to amend the Agreement to increase the total compensation payable under the Agreement by \$150,000.00 for a new contract maximum of \$250,000.00 and must amend item three, “Compensation,” to reflect this change.

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows:

Section 3 “Compensation” is hereby amended to state the following:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, “**Scope of Services.**” **Compensation to Contractor shall not exceed Two Hundred and Fifty Thousand Dollars (\$250,000.00).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled, “**Fiscal Provisions,**” attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.

Exhibit B, “Payment Terms” is hereby amended to state the following:
