Executive Summary:

This amendment increases the contract maximum by \$350,000 to cover placement for Lake County clients. Placement of clients at a North Valley facility is reserved for the most difficult to place clients. The executive team closely follows placement of individuals at this facility, due to the cost. However, for clients with complex needs and challenges North Valley offers a level of care that is much needed and unavailable virtually anywhere else.
