Executive Summary:

This amendment to the Standard Agreement for Specialty Mental Health Services with the Department of Health Care services is required to comply with Cal-AIM initiatives and language. Here are the changes, in short:

In Exhibit A - Attachment 2

- Language changes from "members" to "beneficiaries."
- Added language about Mobile Crisis Services.
- Changes to the description of Day Intensive Treatment Services, which is not a service
 presently offered in Lake County.
- Additional language regarding payments for Indian Health Care Providers. Language referencing Cost Reporting is eliminated.

- Clarifying language has been added regarding the Member Problem Resolution Process.
- Language regarding Periodic Audits has been added.

- Language regarding Medical Assistance Payment Provisions has been updated/changed.
- Language regarding the Claims Adjudication process has been updated to comply with CalAIM payment reform provisions, specifically regarding Federal Financial Participation.

- Updates to State and Federal Laws which Govern the contract
- Update of various definitions, including service definitions to match CalAIM reform
