## **Executive Summary:**

As the County Mental Health Plan, LCBHS is responsible for the placement and payment of acute inpatient psychiatric hospital services. LCBHS works with a variety of hospital across the northern region of the state to find placement for our beneficiaries who require this level of care.

These services are largely reimbursable from Medi-Cal and MediCare, depending on the beneficiaries' aid codes. The County match to be eligible for a claim and reimbursement of Federal Financial Participation (FFP) comes from realignment dollars.
