RECITALS

WHEREAS, the parties now desire to amend the Agreement to increase the total compensation payable under the Agreement by \$300,000.00 for a new contract maximum of \$600,000.00 and must amend item three, "Compensation," to reflect this change.

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows:

3. <u>COMPENSATION</u>. Contractor has been selected by County to provide the services described hereunder in Exhibit A, titled, "Scope of Services." Compensation to Contractor shall not exceed Six Hundred Thousand Dollars (\$600,000.00).
