I attached exhibit D – budget for Clover Creek Hitch Habitat Restoration Project.

To address your 2<sup>nd</sup> question: The HMMP on p. 2 shows that Caltrans has adequate funding to support the Clover Creek Hitch Habitat Restoration Project. *The Blue Lakes Safety Project has approximately \$45,000.00 for mitigation and the Lake 20 Shoulders Project has approximately \$249,000.00 for mitigation.* The language in the coop agreement discloses the current estimate (\$246,491.54) that Lake County anticipates needing to support their project. This amount may change eventually, depending on the most current budget from Lake County.
