

**CONTRACT BETWEEN COUNTY OF LAKE AND BRAIN LEARNING
PSYCHOLOGICAL CORPORATION FOR LEARNING DISABILITY
TESTING AND EVALUATION SERVICES**

This Contract is made and entered into by and between the County of Lake through its Department of Social Services, hereinafter referred to as “LCDSS”, and Brain Learning Psychological Corporation, hereinafter referred to as “Contractor”, collectively referred to as the “parties”. The LCDSS Director shall administer this Contract on behalf of LCDSS.

1. SERVICES.

Subject to the terms and conditions set forth in this Agreement, Contractor shall provide to LCDSS the services described in the Scope of Services attached hereto and incorporated herein as Exhibit A at the time and place and in the manner specified therein. In the event of a conflict in or inconsistency between the terms of this Agreement and Exhibit A – Scope of Services, Exhibit B – Fiscal Provisions, and Exhibit C – Compliance Provisions, the Agreement shall prevail.

2. TERM

This Contract shall commence on July 1, 2026, and shall terminate on June 30, 2029, unless earlier terminated as hereinafter provided. In the event LCDSS desires to temporarily continue services after the expiration of this Contract, such continuation shall be deemed on a month-to-month basis, subject to the same terms, covenants, and conditions contained herein.

3. COMPENSATION

Contractor has been selected by LCDSS to provide the services described hereunder in Exhibit “B” (Scope of Services), incorporated herein by this reference. For the period of July 1, 2026, to June 30, 2027, compensation to Contractor shall not exceed forty-six thousand one hundred and eleven dollars (\$46,116.00). For the period of July 1, 2027, to June 30, 2029, compensation to Contractor shall be the previous year’s compensation, increased by the United States Department of Labor’s Consumer Price Index (CPI) for All Urban Customers in the San Francisco/Oakland/San Jose, CA. metropolitan area. CPI adjusted compensation shall be capped to an upper limit of five percent (5%) per fiscal year.

LCDSS shall compensate Contractor for services in accordance with Exhibit “B” (Fiscal Provisions), attached hereto and incorporated herein. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.

4. TERMINATION

This Contract may be terminated by mutual consent of the parties or by the LCDSS Director upon 30 days written notice to Contractor.

In the event of non-appropriation of funds for the services provided under this Contract, LCDSS Director will terminate this Contract, without termination charge or other liability.

Upon termination, Contractor shall be paid a prorated amount for the services provided up to the date of termination.

5. MODIFICATION

This Contract may only be modified by a written amendment hereto, executed by both parties; however, matters concerning scope of services which do not affect the compensation may be modified by mutual written consent of Contractor and LCDSS Director.

8. TERMS AND CONDITIONS

Contractor warrants that it will comply with all terms and conditions of this Contract and Exhibits, and all other applicable federal, state and local laws, regulations and policies.

9. INTEGRATION

This Contract constitutes the entire agreement between the parties regarding its subject matter and supersedes all prior contracts, related proposals, oral and written, and all negotiations, conversations or discussions heretofore and between the parties.



EXHIBIT “A” – SCOPE OF SERVICES

1. DESCRIPTION OF SERVICES

Contractor shall conduct Learning Disability (LD) assessments for Welfare-to-Work (WTW) participants referred by LCDSS. If a LD exists, Contractor will determine what work activity accommodations are necessary for the participant to participate in employment and training.

2. CONTRACTOR RESPONSIBILITIES

Provide a three-phase LD assessment for each participant referred:

1. Phase 1 – Evaluation/Testing

- a. Schedule each participant referred by LCDSS for evaluation/testing within ten (10) calendar days of the referral date.
- b. Coordinate with LCDSS on space availability for evaluation/testing at a LCDSS facility location convenient to the referred participant.
- c. Contact LCDSS for any questions/concerns.
- d. Conduct evaluation/testing to evaluate the participants:
 - i. Aptitudes/Information Processing, using test instruments approved by LCDSS that may include, but are not limited to, the Wechsler Adult Intelligence Scale (WAIS) or Woodcock-Johnson.
 - ii. Achievement, using test instruments approved by LCDSS that may include, but are not limited to, Wide Range Achievement Test (WRAT3), Test of Adult Basic Education (TABE) or Nelson Denny (reading).
 - iii. Vocational Interest, as needed, to assist in the development of participant’s employment plan.
- e. If no recognized and validated evaluation tools exist in the participant’s primary language, Contractor, using the appropriate bilingual and/or bicultural staff, as necessary, must to the best of staff ability determine if LD exists through:
 - i. The use of other evaluation tools that may provide pertinent information.
 - ii. Discussion that is appropriately tailored to the individual’s cultural background with, and/or observations of, the participant.

- f. Gather sufficient additional information from the participant for report preparation.
 - g. Notify LCDSS immediately if a participant fails to appear for an appointment or fails/refuses to complete evaluation/testing.
2. Phase 2 – Report Preparation
- a. Prepare a typewritten report in a manner easily understood by participant and in a format approved by LCDSS within fifteen (15) calendar days of participant completing evaluation/testing. The report shall contain at minimum:
 - i. Relevant vocational/educational background and history.
 - ii. General aptitude/cognitive level.
 - iii. Other issues, such as physical/mental problems.
 - iv. Areas of strength.
 - v. Areas of deficiency.
 - vi. A summary of the participant’s condition and service needs, including:
 - a. Severity of disability.
 - b. Areas of potential impact, including employment, training, and participation in employment activities.
 - c. Rationale for LD determination/diagnosis.
 - d. Recommendations for additional services as appropriate.
 - e. If identified, any suspected conditions other than a LD so that LCDSS can make the appropriate referral.
 - f. Range of and recommended accommodations/assistive technology to be included in the participant’s employment plan.
 - b. Supply three (3) copies of the report to LCDSS upon completion.

3. Phase 3 – Team Meeting

- a. Upon completion of the report, schedule a team meeting in coordination with the participant’s Employment Services Worker to occur no more than fifteen (15) calendar days later.
- b. Meet face-to-face with the participant and Employment Services Worker at the team meeting to discuss evaluation/testing results and any applicable recommendations for the participant’s employment plan.

4. Staff Training

- a. Contractor will provide annual on-site training at Employment Services to educate staff on Learning Disabilities.

3. REPORTING REQUIREMENTS

Contractor shall submit monthly reports in a format approved by LCDSS by the 10th of the month following the report period.

4. RECORDS RETENTION

Contractor shall prepare, maintain and/or make available to LCDSS upon request, all records and documentation pertaining to this Contract, including financial, statistical, property, recipient and service records and supporting documentation for a period of four (4) years from the date of final payment of this Contract. If at the end of the retention period, there is ongoing litigation or an outstanding audit involving the records, Contractor shall retain the records until resolution of litigation or audit. After the retention period has expired, Contractor assures that confidential records shall be shredded and disposed of appropriately.

5. GRIEVANCE

Contractor must establish a written grievance process for reviewing and attempting to resolve complaints. At a minimum the process shall include all of the following:

- a. Time frames within which a complaint will be acted upon.
- b. Written notification to the complainant of the results of the review, including a statement that the complainant may appeal to the LCDSS if dissatisfied with the results of the contractor's review.
- c. Confidentiality provisions to protect the complainant's rights to privacy. Only information relevant to the complaint may be released to the responding party.

Contractor must notify all individuals of the grievance process available to them by posting notification of the process in visible and accessible areas and advising homebound individuals of the process.

EXHIBIT “B” – FISCAL PROVISIONS

1. COMPENSATION

For the period of July 1, 2026, to June 30, 2027, Contractor shall be compensated at the following rates:

- \$1,383.48 per virtual assessment
- \$1,537.20 per in-person assessment

For the period of July 1, 2027, to June 30, 2029, compensation to Contractor shall be the previous year’s compensation, increased by the United States Department of Labor's Consumer Price Index (CPI) for All Urban Customers in the San Francisco/Oakland/San Jose, CA. metropolitan area. CPI adjusted compensation shall be capped to an upper limit of five percent (5%) per fiscal year.

These fees include all expenses associated with the assessment process, including report preparation and Team Meetings.

2. EXPENDITURE OF FUNDS

LCDSS Director reserves the right to refuse payment to Contractor or disallow costs for any expenditure determined to be unreasonable, out of compliance, or inappropriate to the services provided hereunder.

3. CONTRACTOR’S FINANCIAL RECORDS

Contractor shall keep financial records for funds received hereunder, separate from any other funds administered by Contractor, and maintained in accordance with Generally Accepted Accounting Principles and Procedures and the Office of Management and Budget’s Cost Principles.

4. INVOICES

A. Contractor shall submit monthly invoices, in the format approved by LCDSS, based on actual expenses, no later than the 20th of the month following the month in which services were provided, except for the months of May and June.

B. For the months of May and June:

1. Funding for this Contract is appropriated on a fiscal year basis. LCDSS is not able to compensate Contractor after the close of the fiscal year period.

2. To ensure Contractor is properly compensated, Contractor shall submit invoices based on estimated expenses, including all anticipated costs, no later than June 5th of the fiscal year period.
3. Contractor shall follow up by submitting invoices for actual expenses, as stated hereinabove in Paragraph 4A., including remittance of the full amount of any overpayment that occurred in the event estimated expenses exceeded actual.

C. LCDSS shall review and approve Contractor's invoices and make payment within fifteen (15) days of approval.

5. AUDIT REQUIREMENTS AND AUDIT EXCEPTIONS

- 6.1 Contractor warrants that it shall comply with all audit requirements established by LCDSS and will provide a copy of Contractor's Annual Independent Audit Report, if applicable.
- A. Such audits shall include, but are not limited to, compliance with all applicable Single Audit Requirements as outlined below:

Contractors that expend \$750,000 or more in Federal Awards shall arrange for an audit to be performed as required by the Single Audit Act of 1984, Public Law 98-502, Single Audit Act Amendments of 1996, Public Law 104-156, and Part 200 of the Office of Management and Budget (OMB) Guidance, and a copy submitted to the:

The copy shall be submitted within the earlier of 30 days after receipt of the auditor's report or nine months after the end of the audit period, unless a longer period is agreed to in advance by the cognizant or oversight agency.

Contractor shall ensure that LCDSS-funded expenditures are displayed discretely along with the related federal expenditures in the single audit report's "Schedule of Expenditures of Federal Awards" (SEFA) under the appropriate Catalog of Federal Domestic Assistance (CFDA) number as referenced in Section B of this Article.

For LCDSS contracts that do not have CFDA numbers, the Contractor shall ensure that the LCDSS funded expenditures are discretely identified in the SEFA by the appropriate program name, identifying grant/contract number, and as passed-through the California Department of Social Services.

- 6.2 LCDSS may conduct periodic audits of Contractor's financial records, notifying Contractor no less than 48 hours prior to scheduled audit. Said notice shall include a detailed

listing of the records required for review. Contractor shall allow County, or other appropriate entities designated by County, access to all financial records pertinent to this Agreement.

6.3 Contractor shall reimburse LCDSS for audit exceptions within 30 days of written demand or shall make other repayment arrangements subject to the approval of County.

EXHIBIT “C” – COMPLIANCE PROVISIONS

1. INFORMATION INTEGRITY AND SECURITY

A. Contractor ensures that personal, sensitive and confidential information is protected from inappropriate or unauthorized access or disclosure in accordance with Welfare and Institutions Code Section 10850, LCDSS MEDS Data Privacy and Security Agreement, Lake County Information Security Policy, Health Insurance Portability and Accountability Act (HIPAA), and all other applicable laws, regulations and policies.

B. Contractor shall immediately notify LCDSS of any known or suspected breach of personal, sensitive and confidential information related to Contractor’s work under this Contract.

2. NON-DISCRIMINATION

A. Contractor shall not unlawfully discriminate against any qualified worker or recipient of services because of race, religious creed, color, sex, sexual orientation, national origin, ancestry, physical disability, mental disability, medical condition, marital status or age.

B. Contractor shall comply with and annually sign the LCDSS “Assurance of Compliance” form.

3. ABUSE REPORTING REQUIREMENTS

A. Contractor shall ensure that all known or suspected instances of child abuse or neglect, as defined in Penal Code Section 11165.6, are reported to LCDSS Child Welfare Services.

B. Contractor shall ensure that all known or suspected instances of elder abuse as defined in Welfare and Institutions Code 15610.07, are reported to LCDSS Adult Protective Services.

4. DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS

A. The Contractor certifies to the best of its knowledge and belief, that it and its subcontractors:

1. Are not presently debarred or suspended from federal financial assistance programs and activities, proposed for disbarment, declared ineligible, or voluntarily excluded from participation in covered transactions by any federal department or agency;

2. Have not, within a three-year period preceding this Contract, been convicted of or had a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public transaction; violation of federal or State antitrust statutes or commission of embezzlement, theft,

forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;

3. Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity with commission of any of the offenses enumerated in the preceding paragraph; and

4. Have not, within a three-year period preceding this Contract, had one or more public transactions terminated for cause or default.

B. Contractor shall report immediately to LCDSS Director, in writing, any incidents of alleged fraud and/or abuse by either Contractor or Contractor's subcontractor. Contractor shall maintain any records, documents, or other evidence of fraud and abuse until otherwise notified by LCDSS Director.

5. CHILD SUPPORT

Contractor shall comply with Public Contract Code Section 7110(a), recognizing the importance of child and family support obligations and enforcement including, but not limited to, disclosure of information and compliance with earnings assignment orders as provided in Chapter 8 (commencing with Section 5200) of Part 5 of Division 9 of the Family Code.

6. PAYROLL TAXES AND DEDUCTIONS

Contractor shall promptly forward payroll taxes, insurances, and contributions to designated governmental agencies.

7. CONTRACTS IN EXCESS OF \$100,000

Contractor shall comply with all applicable orders or requirements issued under the following laws:

- A. Clean Air Act, as amended (42 USC 1857).
- B. Clean Water Act, as amended (33 USC 1368).
- C. Federal Water Pollution Control Act, as amended (33 USC 1251, et seq.)
- D. Environmental Protection Agency Regulations (40 CFR, and Executive Order 11738).
- E. Public Contract Code Section 10295.3.

8. INDEMNIFICATION AND HOLD HARMLESS

Contractor shall indemnify and defend the County of Lake and its officers, employees, and agents against and hold them harmless from any and all claims losses, damages, and liability for damages, including attorney's fees and other costs of defense incurred by County of Lake, whether for damage to or loss of property, or injury to or death of person, including properties of County of Lake and injury to or death of County of Lake officials, employees or agents, arising out of, or connected with Contractor's operations hereunder or the performance of the work described herein, unless such damages, loss, injury or death is caused solely by the negligence of County of Lake.

9. STANDARD OF CARE

Contractor represents that it is specially trained, licensed, experienced and competent to perform all the services, responsibilities and duties specified herein and that such services, responsibilities and duties shall be performed, whether by Contractor or designated subcontractors, in a manner according to generally accepted practices.

10. INTEREST OF CONTRACTOR

Contractor assures that neither it nor its employees has any interest, and that it shall not acquire any interest in the future, direct or indirect, which would conflict in any manner or degree with the performance of services hereunder.

11. INSURANCE

Contractor shall not commence work under this Contract until he has obtained all the insurance required herein, certificates of insurance have been submitted to County of Lake, "County", and said insurance has been approved by County of Lake. The certificates of insurance shall contain a provision that coverage afforded under the policies will not be canceled until at least twenty days (20) prior written notice has been given to County of Lake.

Contractor shall not allow any subcontractor to commence work on his subcontract until the insurance required of the subcontractor has been obtained.

Any failure of Contractor to maintain the insurance required by this section, or to comply with any of the requirements of this section, shall constitute a material breach of the entire Contract.

Certificates evidencing the issuance of the following insurance shall be filed with the County of Lake within ten (10) days after the date of execution of this Contract by Contractor:

- (A) **Compensation Insurance:** Contractor shall procure and maintain, at Contractor's own expense, during the term hereof, Workers' Compensation Insurance and Employer's Liability Insurance as required by the State of California, for all employees to be engaged in

work. In case any such work is sublet, Contractor shall require subcontractor similarly to provide Employer's Liability and Workers' Compensation Insurance for all of the latter's employees to be engaged in such work unless such employees are covered by the protection afforded by Contractor's Workers' Compensation Insurance. Employer's Liability Insurance shall be in an amount not less than \$1,000,000 per occurrence

- (B) **Comprehensive Public Liability Insurance:** Contractor shall procure and maintain Comprehensive Public Liability Insurance, both bodily injury and property damage, in an amount of not less than one million dollars (\$1,000,000) combined single limit coverage per occurrence, including but not limited to endorsements for the following coverage: personal injury, premises-operations, products and completed operations, blanket contractual, and independent contractor's liability.
- (C) **Automobile Liability Insurance:** Contractor shall procure and maintain, at Contractor's own expense during the term hereof, Comprehensive Automobile Liability Insurance, both bodily injury and property damage on owned, hired, leased and non-owned vehicles used in connection with Contractor's business in an amount of not less than one million dollars (1,000,000) combined single-limit coverage per occurrence.
- (D) **Subcontractors:** Contractor shall not subcontract for any services contracted herein without LCDSS Director pre-approval in writing. In case of any subcontract, Contractor shall require each subcontractor to provide all of the same coverage as detailed hereinabove. Subcontractors shall provide certificates of insurance naming the County of Lake as additional insured and shall submit new certificates of insurance at least 30 days prior to expiration date. Contractor shall not allow any subcontractor to commence work until the required insurances have been obtained. Contractor shall include all subcontractors as insureds under the aforesaid policies All coverages for subcontractors shall be subject to all of the requirements hereinabove and contain the additional insured endorsement required by Contractor hereinafter.
- (E) **Additional Insured Endorsement: The Comprehensive Public Liability Insurance:** and automobile policies are to contain, or be endorsed to contain, the following provisions:

The County of Lake, its officers, officials, employees, agents, and volunteers are to be covered as additional insureds and shall be added in the form of an endorsement to Contractor's insurance (at least as broad as ISO Form CG 20 10 11 85 or **both** CG 20 10, CG 20 26, CG 20 33, or CG 20 38; **and** CG 20 37 forms if later revisions used). Contractor shall not commence work under this Contract until he has had delivered to County of Lake the Additional Insured Endorsements required herein. Coverage shall not extend to any indemnity coverage for the active negligence of the additional insured in any case where an agreement to indemnify the additional insured would be invalid under subdivision (b) of California Civil Code Section 2782.

(F) Other Insurance Provisions:

1. For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance coverage at least as broad as ISO CG 20 01 04 13 as respects the County of Lake, its officers, officials, employees, agents and volunteers. Any insurance or self-insurance maintained by County of Lake, its officers, officials, employees, agents or volunteers shall be excess of the Contractor's insurance and shall not contribute with Contractor's insurance. Any excess insurance by Contractor shall contain a provision that such coverage shall also apply on a primary and non contributory basis for the benefit of the County of Lake before the County's own primary Insurance policy or self-insurance shall be called upon to protect the Contractor.
2. Any deductibles or self-insured retentions must be declared to and approved by County of Lake. At the option of County of Lake, either: Contractor shall reduce or eliminate such deductibles or self-insurance retentions; or Contractor shall provide a financial guarantee satisfactory to County of Lake guaranteeing payment of losses and related investigations, claim administration and defense expenses.
3. Insurance is to be placed with insurers with a current A.M. Best's rating of no less than A: VII.
4. Insurance coverage in the minimum amounts set forth herein shall not be construed to relieve the Contractor for liability in excess of such coverage, nor shall it preclude Contractor from taking other actions as is available to it under any other provision of the Contract or law. Failure of County of Lake to enforce in a timely manner any of the provisions of this section shall not act as a waiver to enforcement of any of these provisions at a later date.
5. Contractor agrees to waive all rights or subrogation against County of Lake, its officers, officials, employees, agents, and volunteers for losses arising from work performed by Contractor under this Contract.
6. Any failure of Contractor to maintain the insurance required by this section, or to comply with any of the requirements of this section, shall constitute a material breach of the entire Agreement.

12. ATTORNEY'S FEES AND COSTS

If any action at law or in equity is necessary to enforce or interpret the terms of this Contract, the prevailing party shall be entitled to reasonable attorney's fees, costs, and necessary disbursements in addition to any other relief to which such part may be entitled.

13. ASSIGNMENT

It is specifically understood and agreed that, in the making and performance of this Contract, Contractor is an independent contractor and is not an employee, agent or servant of the County of Lake. Contractor is not entitled to any employee benefits. LCDSS agrees that Contractor shall have the right to control the manner and means of accomplishing the result contracted for herein.

Contractor is solely responsible for the payment of all federal, state and local taxes, charges, fees, or contributions required with respect to Contractor and Contractor's officers, employees, and agents who are engaged in the performance of this Contract (including without limitation, unemployment insurance, social security and payroll tax withholding.)

15. OWNERSHIP OF DOCUMENTS

All non-proprietary reports, drawings, renderings, or other documents or materials prepared by Contractor hereunder are the property of the County of Lake.

16. ADHERENCE TO APPLICABLE DISABILITY LAW

Contractor shall be responsible for knowing and adhering to the requirements of Section 504 of the Rehabilitation Act of 1973, the Americans with Disabilities Act, (42 U.S.C. Sections 12101, et seq.). California Government Code Sections 12920 et seq., and all related state and local laws.

17. HIPAA COMPLIANCE

Contractor will adhere to Titles 9 and 22 and all other applicable Federal and State statutes and regulations, including the Health Insurance Portability and Accountability Act of 1996 (HIPAA).

Contractor is aware that this Agreement and any documents provided to LCDSS may be subject to the California Public Records Act (CPRA) and may be disclosed to members of the public upon request. It is the responsibility of the Contractor to clearly identify information in those documents that s/he considers to be confidential under the California Public Records Act. To the extent that LCDSS agrees with that designation, such information will be held in confidence whenever possible. All other information will be considered public. Contractor shall notify LCDSS Director of any CPRA request which includes records produced under this contract, prior to production of records. LCDSS Director reserves the right to review the records Contractor prepares for response, prior to production of records, and may elect to consult with County Counsel prior to approving a CPRA production or response.
