Amendment No. 4 to the AGREEMENT BETWEEN COUNTY OF LAKE AND COMMUNITY BEHAVIORAL HEALTH FOR SPECIALTY MENTAL HEALTH SERVICES FOR FISCAL YEARS 2023-24, 2024-25 and 2025-26

This Amendment No. 4 to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Community Behavioral Health, hereinafter referred to as "Contractor," collectively referred to as the "parties."

RECITALS

WHEREAS, the County entered into an Agreement with Contractor effective August 1, 2023; and

WHEREAS, the parties amended the Agreement the first time on February 29, 2024 to increase the rates for Licensed Professionals of the Healing Arts effective November 1, 2023 and to increase the overall contract maximum to meet service demands and projections for services; and

WHEREAS, the contract was amended a second time on April 9th, 2024 to correct an error in the recitals of the Amendment No. 1 where the increase in contract maximum was noted as \$600,000 when it should have read an increase of \$2,600,000 for a total maximum compensation of \$3,200,000; and

WHEREAS, the contract was amended a third time on August 5th, 2024 to increase the total compensation payable under the Agreement by \$12,400,000.00 for a new contract maximum of \$15,600,000.00 and must amend item three, "Compensation," to reflect this change.

WHEREAS, the parties now desire to amend the Agreement a fourth time to add the addition of a Licensed Vocational Nurse and a Psychologist, with no change to the contract max, and must amend Exhibit B, "Fiscal Provisions," to reflect this change.

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows:

Section 6.1 of EXHIBIT B – "Fiscal Provisions" is hereby amended to state as follows:
