11 **THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE ORDAINS AS**  
12 **FOLLOWS:**

14                   **Section 1:** Subsection (k) of Section 56.3 of Chapter 14 of the Lake County Code is hereby  
15 added as follows:

17                   “(k) Deputy County Counsel Attorneys: Those attorneys-at law who occupy positions in  
18 the County Counsel Office, excluding members of the General Management Unit and  
19 members of the Attorneys Unit.”

21                   **Section 2:** Subsection (h) of Section 56.3 of Chapter 14 of the Lake County Code is  
22 amended as follows:

24                   “(h) Attorneys: Those attorneys-at-law who occupy positions in the District Attorney's,  
25 Public Defenders, and Child Support Services Department, excluding members of the  
26 General Management Unit and members of the Deputy County Counsel Attorneys Unit.”

28                   **Section 3:** All ordinances or parts of ordinances or resolution or parts of resolution in  
conflict herewith are hereby repealed to the extent of such conflict and no further.

**Section 4:** This ordinance shall take effect on the \_\_\_\_ day of \_\_\_\_\_ 2026 and before expiration of fifteen days after its passage it shall be published at least one in a newspaper of general circulation in the County of Lake.
