UP 21-27 Seigler Springs North Cultivation Project:
 Is enrolled as a Tier 2L site under WDID 5S17CC429129; they have been enrolled since 10/23/2020;

The responsible parties and APNs in the RFR match their enrollment. All annual reports have been submitted and invoices have been paid.

Cultivation Area covered: 174,240 SF; Disturbed Area covered: 180,000 SF; An SMP and NMP were submitted in December of 2020. It appears that these technical reports will need to be updated. The maps within SMP show a different layout of proposed roads that those in the RFR documents. The SMP also states that there will be up to 10 acres of disturbed area. Before development begins on this site, the Dischargers will need to submit a Change of Information to update the proposed disturbed area (and cultivation area if necessary) and will need to amend their SMP to match current proposed plans.

Records at this office were reviewed to determine if this project could adversely affect cultural resources.

Please note that use of the term cultural resources includes both archaeological sites and historical buildings and/or structures. The review for possible historic-era building/structures, however, was limited to references currently in our office and should not be considered comprehensive.

Project Description:

The applicant is requesting approval of a Major Use Permit to allow the following licenses: Four (4) A- Type 3 "Outdoor": Outdoor cultivation for adult use cannabis without using light deprivation and/or artificial lighting in the canopy area at any point in time from 10,001 to one acre, inclusive, of total canopy size on one premises. One (1) Type 13 "Distributor Transport Only, Self-distribution": The transport of medicinal cannabis goods between entities licensed pursuant to California Code. According to the applicant's application package, the proposed project will include the following: Outdoor Cultivation (Total mature cannabis canopy on ground or in planter bags with imported soil: 174,240 sq. ft., Total cultivation area: 435,600 sq. ft.). The facility layout will be as follows: One (1) proposed 15'x15'x6' chain link trash enclosure, two (2) proposed 8'x40'x8' proposed shipping containers, one (1) proposed 40' x 20' compost area, five (5) 2,500 gallon water tanks, one (1) Chemical storage area, and one (1) compost and soil mixing area.


