13 and Construction executed a construction contract, in the amount of \$1,075,961.35, for
14 the construction of the Socrates Mine Road (PM 2.61) Landslide Repair Project (FEMA-
15 4308-DR-CA, LKLCC56) and Socrates Mine Road (PM 3.41) Landslide Repair Project
16 (FEMA-4301-DR-CA, LKLCC03);

17 **WHEREAS**, on November 7, 2024, the Socrates Mine Road (PM 2.61)
18 Landslide Repair Project (FEMA-4308-DR-CA, LKLCC56) and Socrates Mine Road
19 (PM 3.41) Landslide Repair Project (FEMA-4301-DR-CA, LKLCC03) were completed
20 to the satisfaction of the Director of Public Works; and

21 **WHEREAS**, the Director of Public Works prepared the Notice of Completion for
22 the Socrates Mine Road (PM 2.61) Landslide Repair Project (FEMA-4308-DR-CA,
23 LKLCC56) and Socrates Mine Road (PM 3.41) Landslide Repair Project (FEMA-4301-
24 DR-CA, LKLCC03).

25 **NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors (1)
26 accepts the work of the Socrates Mine Road (PM 2.61) Landslide Repair Project
27 (FEMA-4308-DR-CA, LKLCC56) and Socrates Mine Road (PM 3.41) Landslide Repair
