Executive Summary

Briefly describe the project you are proposing and what you hope to accomplish.

The proposed project will strengthen the Lake County Search and Rescue Team's capacity to navigate the rugged and remote terrain that defines Lake County, enabling faster responses, reducing search durations, and ultimately saving lives.

Describe the target population your project aims to reach. This includes general demographic information and socio-economic context.

Lake County SAR serves a base population of 68,000 residents with a daily fluctuation of tourists, many of whom utilize public lands. Lake County spans 844,800 acres of rugged mountains, rolling hills, and broad valleys, with over half designated as public lands, features 350+ miles of offroad trails and elevations ranging from 640 to 7,046 feet. Lake County faces significant economic challenges, including a median household income nearly \$20,000 below the California average, a poverty rate higher than the state norm, and a disproportionately high percentage of residents with disabilities.

What specific activities will this funding support?

This funding will enhance SAR operations, enabling 24/7, year-round response to locate, assist, and retrieve lost or distressed individuals. Over 85% of callouts involve lost, missing, or stranded people, with the remainder supporting mutual aid in rugged terrain. The project will support the existing "Quad Team" by funding two new ATVs equipped with basic rescue equipment and gear, increasing the team's capacity by 66%. Currently, the team of 8 share three ATVs, often requiring volunteers to use their own equipment, creating undue financial and operational strain. Utilizing an ATV in place of volunteers on foot is 5-10 times faster, covers up to 10 times more ground, and provides for a significantly higher load capacity, resulting in shorter duration operations, vital lifesaving equipment/supply delivery and more successful rescues.

Please list any organizations you plan to partner with during the implementation of the project.

There are no direct partner organizations for implementation of this project, however, the project will support mutual aid callouts where ATVs are needed for SAR operations, often in neighboring jurisdictions. Most County SAR teams rely heavily on timely mutual aid response. In the last year, Lake County has been unable to fill 62% of requests, due at times to the lack of ATVs. This project will bolster Lake County's ability to provide timely response when requested.

What challenges or roadblocks do you anticipate encountering? How will you navigate these challenges?

Potential challenges or roadblocks may include supply chain issues. This will be remediated by assessing and utilizing multiple suppliers.

How do you define project success?

Project success is defined by enhanced Search and Rescue (SAR) capacity that results in faster response times, expanded coverage, and improved rescue outcomes for Lake County residents, visitors and mutual aid efforts. Success is measured by the operational impact, lives saved, increased capacity and the reduction of economic strain on volunteers currently bearing personal expenses to fulfill their critical roles.

For projects that will continue beyond the grant period, please describe your sustainability plans.

Lake County SAR has a strong foundation for sustaining the equipment funded by this project beyond the grant period. SAR has established maintenance protocols and trained personnel to ensure the longevity and operational readiness of ATVs and other essential gear. A portion of the annual budget, as well as additional fund seeking, supports operational expenses including maintenance. While the purchase of new quads is unattainable without the funding requested, Lake County SAR is committed to maintaining its enhanced capacity beyond the grant period.

Lake County SAR is dedicated to supporting residents and visitors during times of distress, whether due to natural disasters or, more commonly, assisting lost, missing, or stranded individuals in remote areas. The team has extensive experience in procurement and grant management, ensuring that project deliverables are met efficiently and effectively. Through this funded project, SAR's overall capacity will be significantly enhanced, allowing for improved response and support in critical situations.
