

**AMENDMENT NO. 1 to the AGREEMENT BETWEEN COUNTY OF  
LAKE AND COMMUNITY BEHAVIORAL HEALTH FOR SPECIALTY  
MENTAL HEALTH SERVICES FOR  
FISCAL YEARS 2023-24, 2024-25 and 2025-26**

**This 1<sup>st</sup> Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Community Behavioral Health, hereinafter referred to as “Contractor,” collectively referred to as the “Parties.”**

**RECITALS**

**WHEREAS**, the County entered into an Agreement with Contractor effective August 1, 2023; and

**WHEREAS**, the County and Contractor have identified a need to expand of the Scope of Services to include management of access to services; and

**WHEREAS**, utilization of this Contractor has increased to meet beneficiary needs and a new rate for Licensed Professionals of the Healing Arts (LPHA) has been negotiated; and

**WHEREAS**, the parties now desire to amend the Agreement to increase the total compensation payable under the Agreement by \$600,000 for a new contract maximum of \$3,200,000; and

**WHEREAS**, item three (3) of the Agreement, “**Compensation**,” and Exhibit B, “**Fiscal Provisions**,” item six (6), “**Payment Terms**,” must be amended to reflect these changes.

**Section 3, “Compensation” is hereby amended to state the following:**

**NOW THEREFORE**, based on the foregoing recitals, the parties hereto agree as follows:

**3. COMPENSATION**. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, “**Scope of Services**.” **Compensation to Contractor shall not exceed Three Million, Two Hundred Thousand Dollars (\$3,200,000.00).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled “**Fiscal Provisions**” attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this agreement.

**Section 6 of Exhibit B “Payment Terms” is hereby amended to state the following:**

**EXHIBIT B – FINANCIAL PROVISIONS**

**6. PAYMENT TERMS**. County shall reimburse Contractor for services provided to Lake County Medi-Cal beneficiaries per the schedule below **effective November 1, 2023:**

\*Travel expenses connected to on-site services including mileage, flights, hotels and drive time will be billed to LCBHS

\*Commute time will not be billed additionally if built into schedule

\* Every 4 hours of service will result in an additional 30 minutes of billable time for bridged care.
