AN ORDINANCE AMENDING SECTION 2-3A.2 and 2-3B OF ARTICLE 1, CHAPTER 2
OF THE LAKE COUNTY CODE

WHEREAS, Lake County Code Section 2-3A.2, had historically provided that Supervisors shall, in addition, be entitled to mileage and travel expenses incurred in conduct of official business in accordance with the County mileage and expenses policies. Supervisors shall also be entitled to mileage for each mile necessarily traveled going to and from their residence to the Courthouse in Lakeport, California; such mileage shall be deemed to be in the conduct of official business for purposes of this section. The mileage reimbursement rate shall be computed at the rate of twenty-seven cents (\$0.27) per mile; and

WHEREAS, Lake County Code Section 2-3B.1, had historically provided that Grand Jurors shall receive mileage reimbursement at the rate of thirty-nine cents (\$0.39) per mile; and

WHEREAS, Lake County Code Section 2-3B.2, had historically provided that Supervisors shall, in addition, be entitled to mileage and travel expenses incurred in the conduct of official business in accordance with the County mileage and expense policies. Supervisors shall also be entitled to mileage for each mile necessarily traveled going to and from their residence to the Courthouse in Lakeport, California; such mileage shall be deemed to be in the conduct of official business for purposes of this section. The mileage reimbursement rate shall be computed at the rate of thirty-nine cents (\$0.39) per mile; and

WHEREAS, the County is updating the County of Lake Travel and Reimbursement policy to tie mileage reimbursement rates to an annually updated resource; and

WHEREAS, it was determined that the Board of Supervisors are considered to be full-time employees and as such will be reimbursed subject to the County of Lake Travel and Reimbursement policy; and

WHEREAS, the County has determined that mileage to the Courthouse in Lakeport, California would be considered commuting mileage and as such taxable income, if paid; and

WHEREAS, the County has determined that by removing specified mileage reimbursement amounts in Lake County Code Sections 2-3A.2 and 2-3B will prevent the need for annual amendments.

NOW THEREFORE, the Board of Supervisors of the County of Lake ordains as follows:

Section 1: The Board of Supervisors of the County of Lake hereby amends section 2-3A.2 and section 2-3B of Article 1, Chapter 2 of the Lake County Code to read as follows:

“Sec. 2-3A. – Compensation of the Board of Supervisors

3A.2 Supervisors shall, in addition, be entitled to mileage and travel expenses incurred in conduct of official business in accordance with the County of Lake Travel and Reimbursement Policy.”

“Sec. 2-3B. – Trial and Grand Jurors

3B.1 *Mileage*. Grand Jurors shall receive mileage reimbursement in accordance with the County of Lake Travel and Reimbursement Policy.”

Section 2: It can be seen with certainty that there is no possibility this Ordinance may have a significant effect on the environment.

Section 3: All Ordinances or parts of Ordinances or Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict and no further.

Section 4: This ordinance shall take effect thirty (30) days after its passage. Before the expiration of fifteen (15) days after passage of this ordinance, it shall be published once with the names of members of the Board of Supervisors voting for and against the ordinance, in a newspaper published in the County of Lake, State of California.
