

**Amendment No. 4 to the AGREEMENT BETWEEN COUNTY OF LAKE  
AND LAKE COUNTY OFFICE OF EDUCATION FOR THE MENTAL  
HEALTH STUDENT SERVICES ACT GRANT PROGRAM-BASED  
SPECIALTY MENTAL HEALTH SERVICES FOR FISCAL YEAR 2021-26**

**This Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Lake County Office of Education, hereinafter referred to as “Contractor,” collectively referred to as the “parties.”**

**RECITALS**

**WHEREAS**, the parties hereto have entered into an Agreement dated September 1, 2021, under which the contractor will provide school-based specialized mental health services to the residents of Lake County as part of the Mental Health Student Services Act (MHSSA) grant funding through the Mental Health Services Oversight and Accountability Commission (MHSOAC); and

**WHEREAS**, this Agreement was Amended the first time on January 25, 2022, to reflect updated staffing and the associated budget; and

**WHEREAS**, this Agreement was Amended a second time on May 9, 2023, to reflect an updated budget; and

**WHEREAS**, this Agreement was Amended a third time on January 9, 2024, to reflect an updated budget; and

**WHEREAS**, the parties now desire to amend the Agreement a fourth time to modify Exhibit B, “**Fiscal Provisions**,” of the Agreement to reflect necessary program and budget changes approved by the MHSOAC.

**NOW, THEREFORE**, the parties hereto agree to the following Amendment to the Agreement:

**Exhibit “B,” Section 3, “Payment Terms” is hereby amended to the state the following:**

**3. PAYMENT TERMS.** The County shall provide Seventy-One Thousand, Eight Hundred Thirty-Five Dollars and Eighty-Three Cents \$71,835.83 in funds in Grant Year One (1), Four Hundred Six Thousand and Six One Hundred Twenty One Dollars and Eighty Six Cents \$406,121.86 in funds for Gant Year Two (2), Six Hundred Fifty Thousand Nine Hundred Sixty Six Dollars and Thirty Eight Cents \$650,966.38 in Grant Year Three (3) Eight Hundred Fifty Eight Thousand Five Hundred Eighty Five Dollars and Sixty Nine Cents \$858,585.69 in Grant Year Four (4) One Hundred Twenty Four Thousand Seven Hundred Forty One Dollars and Fifty Eight Cents \$124,740.58 In Grant Year Five (5) received from the Mental Health Student Services Act grant for a total maximum payable of **Two Million, Seventy One Thousand, Eight Hundred and Ninety Six dollars (\$2,112,250.00).**
