

**AMENDMENT NO. 3 TO AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN
THE COUNTY OF LAKE AND LAKE COUNTY PEG-TV**

This Amendment No. 3 to Agreement is made and entered into this 14th day of July, 2026 by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Lake County PEG-TV (hereinafter referred to as "CONTRACTOR").

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated June 11, 2024, under which CONTRACTOR has provided professional videography services to COUNTY; and

WHEREAS, the parties approved the 1st amendment to the agreement on March 18, 2025 to increase the compensation for FY 24-25 to a maximum not to exceed \$17,000; and

WHEREAS, the parties approved the 2nd amendment to the agreement on December 19, 2025 to increase the compensation for the FY 25-26 to a maximum not to exceed \$22,000; and

WHEREAS, the parties wish to further amend the agreement to the total compensation for the FY 26-27 as well as update Exhibit C with Lake County PEG's latest cost of services provided based on their recently approved Lake County PEG Fee Schedule.

NOW, THEREFORE, the parties hereby agree as follows:

1. Section 2 ("Contractor Compensation") is hereby amended to read:

COUNTY shall compensate CONTRACTOR for said services at the rate described in Exhibit C, not to exceed \$17,000 for FY 24/25, \$22,000 for FY 25/26, and \$22,000 for FY 26/27 and shall be based upon a written statement from CONTRACTOR detailing the services provided using the process described in Exhibit C, attached hereto and incorporated herein by reference, titled Fiscal Provisions. Contract shall commence upon the date of approval from the Lake County Board of Supervisors and terminate on June 30, 2027.

2. Exhibit C ("Fiscal Provisions"), Section 2 ("Payment Terms") is hereby amended to read:

- a. COUNTY shall reimburse CONTRACTOR on a monthly basis for professional videography services provided to Lake County Municipal Advisory Councils (i.e., costs associated with the videographer's time) at the following hourly rates:
 - i. For FY 24/25 & FY 25/26, \$40 per hour
 - ii. For FY 26/27, \$50 per hour

- b. In addition to the cost of a videographer, a per-meeting fee for equipment use will be charged, as follows:
- i. For FY 24/25 & FY 25/26, \$50 per meeting
 - ii. For FY 26/27, \$55 per meeting

Except as specifically modified herein, the Parties agree all other terms and conditions of the original Agreement shall remain in full force and effect.
