3 **RESOLUTION ADOPTING EMERGENCY OPERATIONS PLAN**
4 **FOR THE COUNTY OF LAKE AND THE LAKE COUNTY OPERATIONAL AREA**

6 WHEREAS, Article 10 of the California Emergency Services Act (California
7 Government Code, Section 8610) mandates that Operational Areas develop plans for meeting
8 any condition constituting a local emergency or state of emergency, including, but not limited to,
9 earthquakes, natural or manmade disasters specific to that jurisdiction, or state of war
10 emergency, which minimize injury, loss of life and damage caused by a major emergency or
11 disaster; and

12 WHEREAS, the Lake County Sheriff's Office of Emergency Services is the identified
13 disaster agency for the County (Ordinance 3035, enacted November 2105) and is responsible for
14 the planning and coordination of the local disaster services; and

15 WHEREAS, the existing 2020 Lake County Emergency Operations Plan ("EOP") has
16 become dated and does not meet the requirements of the National Incident Management System
17 and the Standardized Emergency Management System; and

18 WHEREAS, the Lake County Sheriff's Office of Emergency Services, in conjunction
19 with the offices, departments, municipal agencies and other key partners in the Operational Area,
20 has developed an updated EOP for the County of Lake and the Lake County Operational Area,
21 and said plan has been made available to all concerned agencies; and the public for review and
22 comment; and

1 WHEREAS, the Lake County Disaster Council was convened on October 21, 2024, and
2 approved by motion a recommendation to forward the proposed EOP to the Board of Supervisors
3 for adoption for the County of Lake and the Lake County Operational Area; and

4 RESOLVED FURTHER, that the Sheriff; in his capacity as Emergency Service Director,
5 and the Emergency Services Manager, in her appointive capacity as coordinator of the
6 Operational Area and as Office of Emergency Services Manager, shall exercise due diligence to
7 maintain the EOP as a vital, current and dynamic plan to address all hazards; and

8 NOW, THEREFORE, BE IT RESOLVED, by the Lake County Board of Supervisors,
9 that the attached EOP dated April 2, 2025, is hereby approved and adopted and supersedes all
10 previous versions.

11 This resolution was passed and adopted by the Board of Supervisors of the County of
12 Lake, State of California, at a regular meeting thereof on this 2nd day of April, 2025 and shall be
13 effective immediately by the following vote:
