AMENDMENT No. 4 to the AGREEMENT BETWEEN COUNTY OF LAKE AND REDWOOD COMMUNITY SERVICES, INC. FOR THE LAKE COUNTY WRAP PROGRAM, FOSTER CARE PROGRAM, AND INTENSIVE SERVICES FOSTER CARE (ISFC) PROGRAM FOR SPECIALTY MENTAL HEALTH SERVICES FOR FISCAL YEARS 2022-23, 2023-24, and 2024-25

This 4th Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Redwood Community Services, Inc., hereinafter referred to as "Contractor," collectively referred to as the "parties."

RECITALS

WHEREAS, the County entered into an Agreement with Contractor for the provision of Specialty Mental Health Services effective July 1, 2022; and

WHEREAS, the Agreement was amended on or about June 28, 2023, to incorporate CalAIM service and payment reform requirements into the Agreement as well as to increase the compensation payable under the Agreement; and

WHEREAS, the Agreement was amended on or about March 19, 2024, to include Peer Support Services in the Agreement; and

WHEREAS, the Agreement was amended a third time to increase the compensation by an additional \$2.1 million dollars for Fiscal Year 2024-25 services; and

WHEREAS, the Agreement must be amended a fourth time to and increase the compensation by \$500,000.00 for a new contract max of \$6,200,000.00

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows: **Item 3, "Compensation," is hereby amended to state as follows:**

3. <u>COMPENSATION</u>. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, "**Scope of Services**" attached hereto and incorporated herein. **Compensation to Contractor shall not exceed Six Million Two Hundred Thousand Dollars** (\$6,200,000.00).

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled "**Fiscal Provisions**," attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement.
