A RESOLUTION AMENDING THE MOTION BY THE BOARD APPROVING THE RECOMMENDED BUDGET FOR FY 2025-2026 BY ADJUSTING REVENUES IN BUDGET UNIT 1072 – CANNABIS AND 8109 – WATERSHED PROTECTION DISTRICT

WHEREAS, Government Code Section 29130 provides that revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting; and

WHEREAS, the revenues are being amended due to the denial of the State Grant for QZ Mussel for essential prevention activities and the adjustment Fiscal Year 2025-2026 budget and will be included in the Adopted Budget; and

WHEREAS, the Cannabis Tax budget allows for 30% of the revenues to be allocated to Planning, Code Enforcement, Water Resources and Environmental Health and there is currently an unallocated balance of \$266,445.86; and

WHEREAS, the remaining funds are available in the Cannabis Tax budget which allows for 30% of the revenues to be allocated to Economic Development, Housing, and Risk Reduction in the amount of \$75,000; and

WHEREAS, monies in the amount of \$341,445.86 from the Cannabis Tax Revenues have been allocated to the Watershed Protection District for Quagga Mussel Prevention Activities; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lake, State of California, that it finds, determines, and hereby declares that the County of Lake Recommended Budget for Fiscal Year 2025-2026 is amended as follows:
