AN ORDINANCE AMENDING SECTION 56.3 OF CHAPTER 14 (PERSONNEL)
OF THE LAKE COUNTY CODE TO ESTABLISH A DEPUTY COUNTY COUNSEL
ATTORNEYS UNIT, ADD POSITIONS TO THE DISTRICT
ATTORNEY UNIT, AND UPDATE AND CHANGE THE TITLE OF THE DISTRICT
ATTORNEY UNIT TO ATTORNEYS TO REFLECT CHANGES IN MEMBERSHIP

THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE ORDAINS AS FOLLOWS:

Section 1: Subsection (k) of Section 56.3 of Chapter 14 of the Lake County Code is hereby added as follows:

- "(k) Deputy County Counsel Attorneys: Those attorneys-at law who occupy positions in the County Counsel Office, excluding members of the General Management Unit and members of the Attorneys Unit."
- <u>Section 2:</u> Subsection (h) of Section 56.3 of Chapter 14 of the Lake County Code is amended as follows:
 - "(h) Attorneys: Those attorneys-at-law who occupy positions in the District Attorney's,
 Public Defenders, and Child Support Services Department, excluding members of the
 General Management Unit and members of the Deputy County Counsel Attorneys Unit."

<u>Section 3:</u> All ordinances or parts of ordinances or resolution or parts of resolution in conflict herewith are hereby repealed to the extent of such conflict and no further.
