Lake County Home Hardening Program

What is home hardening?

Home hardening addresses the most vulnerable components of your house with building materials and installation techniques that increase resistance to heat, flames, and embers that accompany most wildfires.

NCO has partnered with California Office of Emergency Services (Cal OES), the California

Department of Forestry and Fire Protection (CAL FIRE), and the County of Lake for the Lake County

Home Hardening Program. You can learn more about this partnership on the California

The program has committed to implementing **home hardening** measures for residential homes within the Kelseyville Riviera Community Association over the next 2-year period.

The program will provide defensible space and home hardening retrofit measures to hundreds of residence. With nearly 1,500 homes prequalified within the specified area, the emphasis of the initiative is on implementing a targeted wildfire cluster resilience strategy.

Lake County homes eligible for this program *must be within* the jurisdiction of the Kelseyville Riveria Community Association. Homes outside this jurisdiction are not currently eligible. The program will offer Riveria homeowners the opportunity to retrofit, harden, and create defensible space while targeting low-to-moderate income households.

The Lake County Home Hardening Initiative is currently in the mid-stages of development and will begin to open applications in a phased approach in the near future.

Mission & Values

Rural Communities Housing Development Corporation's (RCHDC) mission is to provide decent, affordable housing to low- and moderate-income persons. - Owns 10 rental developments and fee manages 12 communities reserved for qualified Low-Income Families
 Together these 22 developments consist of 663 units
- Owns 10 rental developments and fee manages 2 communities consisting of 372 units reserved exclusively for individuals with various forms of disabilities, status of homelessness or other special needs.
- · Presently has 40 units under construction
- · Presently has 247 units in the predevelopment phase
- · Facilitated 22 homes becoming permanently affordable through the Community Land Trust.

The organization's current vision further emphasizes our commitment to the people we serve RCHDC is committed to being an industry leader on the North Coast of California, providing low and moderate-income housing. The agency strives to be a strong, dynamic, and flexible organization; effective at achieving its mission through its efforts and its partnerships-public and private.

RCHDC contracts with various community-based non-profit service providers and County entities in Northern California for the provision of behavioral health and supportive services for our permanent supportive housing developments. RCHDC also has a proven track record and extensive history of sustainable business practices and financial and personnel management systems in place. An annual audit is completed for each development operated by RCHDC as well as a consolidated audit of the organization.
