

# **AMENDMENT NO.1 TO THE AGREEMENT BETWEEN COUNTY OF LAKE & KNO'QOTI NATIVE WELLNESS, INC. FOR FISCAL YEARS 2025-2030**

This Amendment is made and entered into by and between the County of Lake ("County") and Kno'Qoti Native Wellness, Inc. ("Contractor"), collectively referred to as the "Parties."

## **Recitals**

WHEREAS the Parties entered into an Agreement commencing July 1, 2025 for the provision of ElevateED youth prevention and opioid abatement services using Opioid Settlement Funds (OSF), in an amount not to exceed \$1,000,000;

WHEREAS, Exhibit B of the Agreement provides for reimbursement-based payments;

WHEREAS, Exhibit B, Section 5 identifies the purchase of a passenger vehicle in the amount of \$65,000 as an approved Year 1 program expense;

WHEREAS, Contractor has requested advance payment specifically for the vehicle purchase in order to secure a vehicle from a local dealership and begin program implementation;

WHEREAS, the County finds it is in the public interest to allow a one-time advance payment solely for the purchase of the approved vehicle, subject to reconciliation and documentation requirements;

## **Amendment**

### **1. Amendment to Exhibit B – Payment Terms**

A new Section 1.6 – Advance Payment for Vehicle Purchase is added:

#### **1.6 Advance Payment – Vehicle Purchase**

- a. Notwithstanding Sections 1.1 through 1.5 of this Exhibit, the County may issue a one-time advance payment not to exceed Sixty-Five Thousand Dollars (\$65,000) for the purchase of the vehicle identified in Exhibit B, Section 5, Year 1 Budget.
- b. Contractor shall submit a written request for advance payment including:
  - A purchase quote or invoice from the dealership;
  - Proof that the vehicle will be used solely for ElevateED program activities.
- c. Contractor shall submit final proof of purchase (bill of sale, registration, and proof of insurance).
- d. If the vehicle is not purchased within 60 days of disbursement, unspent funds shall be returned to County.
- e. This advance shall be reconciled against total compensation and shall not increase the total contract amount.

### **2. No Other Modifications**

Except as expressly amended herein, all other terms, conditions, and provisions of the Agreement remain unchanged and in full force and effect.


3. Effective Date
