A RESOLUTION TO AMEND THE ADOPTED BUDGET FOR FY 22-23 BY INCREASING REVENUE IN FUND 200 LAKE COUNTY WATERSHED PROTECTION DISTRICT BUDGET TO APPROPRIATE UNANTICIPATED REVENUE

WHEREAS, Government Code Section 29130 provides that unanticipated revenue may be made available for specific appropriation at any regularly scheduled or properly noticed special meeting by a four-fifth's vote of the Board, and;

WHEREAS, the Lake County Watershed Protection District (hereafter "District"), has unanticipated revenues due to the allocation of funds from the County of Lake Department of Agriculture totaling \$137,000, and;

WHEREAS; The District has the authority to manage and control vegetation throughout the upper lake and Scotts Creek levee system as part of the flood management responsibilities, and;

WHEREAS, the District has the authority to construct, operate, and maintain the Highland Springs Recreation Area including Highland Springs Park and Reservoir; and;

WHEREAS, the allocated funds will be used to purchase equipment to conduct invasive species plant management on District managed properties; and;

## NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. Revenue in Fund 200, Budget Unit 8109, Revenue Account 81-22 shall be increased by \$137,000 and
- 2. The sum of \$137,000 in unanticipated revenue will be appropriated as \$27,000 in Fund 200, Budget Unit 8109, Account Number 27-00 for small tools, and as \$110,000 in Fund 200, Budget Unit 8109, and Account Number 62-74 as a Capital Asset for tractor and mower equipment.
