A RESOLUTION APPROPRIATING UNANTICIPATED REVENUE FOR FUND 251 LAKE COUNTY SANITATION DISTRICT LANDS END/ SOUTH LAKEPORT SEWER IN THE AMOUNT OF \$38,000 TO PROFESSIONAL AND SPECIALIZED SERVICES

WHEREAS, Government Code section 29130 provides that the governing body may, by a four-fifths (4/5) vote, make amounts that are in excess of anticipated amounts be made available for appropriation; and

WHEREAS, the FY 24/25 estimated total revenue for fund 251 LACOSAN Lands End/ South Lakeport Sewer was \$195,327 and actual received was \$233,522.61; and

WHEREAS, funds were budgeted in FY 24/25 in the amount of \$203,200 for Professional and Specialized Services; and

WHEREAS, LACOSAN Lands End/ South Lakeport Sewer sends its sewer flows to the City of Lakeport Wastewater treatment plant and the City of Lakeport charges LACOSAN Lands End/ South Lakeport Sewer a proportion cost of their treatment and disposal cost quarterly; and

WHEREAS, Invoices from the City of Lakeport pertaining to Sewer use in 2024 by the County (Special Districts) have exceeded the FY 24/25 Budget;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors, Lake County Sanitation District, that the following revisions to the Fiscal Year 2024-25 Adopted Budget of the County of Lakeare hereby ordered and approved:
