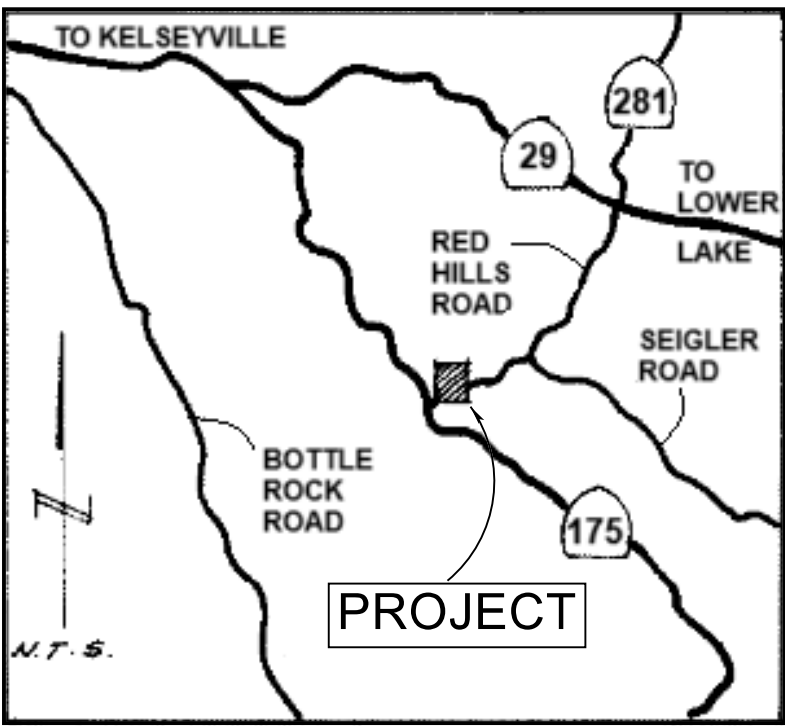


TENTATIVE PARCEL MAP

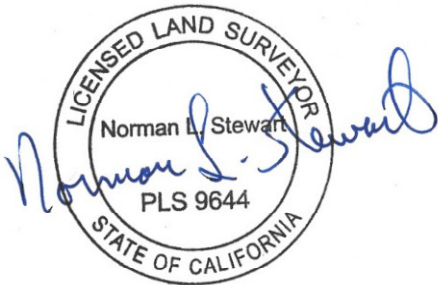
