

Keefe Commissary Services Amendment Two

THIS SECOND AMENDMENT (“Second Amendment”) has an effective date April 7, 2024 (Second Amendment Effective Date”) between the County of Lake, a political subdivision of the State of California (“County”) and Keefe Commissary Network (“Vendor”) with an address of 13269 Corporate Exchange Dr, Bridgeton, Missouri, 63044.

Whereas, Effective April 7, 2020, County and Vendor entered into an Inmate Commissary Services Agreement (“Agreement”), under which the Vendor agreed to provide commissary and tablet services to the inmate population at the Lake County Jail. The parties hereto desire to further amend the terms of the Agreement to modify **SECTION 3 TERM AND TERMINATION**.

1. Section III. TERM, Subsection 1 is hereby deleted in its entirety and replaced with the following.
 - a. County and Vendor entered into an Inmate Commissary Services Agreement effective April 7, 2020, for an initial term of 3 years with an expiration date of April 7, 2023 (“Initial Term”). The County entered the First Renewal Term on April 7, 2023 (First Renewal Term). The County exercises its right to further renew this Agreement for an additional 1-year term which shall begin on April 7, 2024, and remain in force throughout the renewal term with an expiration date of April 7, 2025 (“Second Renewal Term”). This agreement shall not bind, nor purport to bind, County for any contractual commitment in excess of the Renewal Term(s). However, County, at its sole option shall have the right to renew this agreement on a month-to-month basis (not to exceed 12 months), with 30 days written notice to the Vendor prior to the expiration of the Second Renewal Term of this Agreement. In the event the County exercises such right, all terms and conditions, requirements, and specifications of this Agreement and its Amendments, shall remain the same and apply during the renewal term(s). This Agreement will not automatically renew.
2. **Except as expressly modified by this Second Amendment, the provisions, and conditions of the original Agreement, as amended, are unchanged and shall remain in full force and effect. The original Agreement, as expressly modified by this Second Amendment, is the complete agreement of the parties and supersedes all prior or contemporaneous agreements and representations whether written or oral and may not be further modified or amended except by written amendment.**
