#### Digital Watchdog Video Surveillance

Advanced Security to install (1) 4TB Digital Watchdog server with (1) UPS in the IT room. Digital Watchdog software/products are NDAA compliant and provides the ability to view surveillance from any on site monitor or any smart device if connected to the site's network if desired.

Advanced Security to install (1) 4mp vari focal turret cameras through interior of the building and (4) 8mp vandall ball turret cameras on the exterior of the building. Camera locations are depicted in the attached site map and provide a general reference for area of coverage. Advanced Security Systems to run conduit from the west side of the building, under the overhang to enable the ability to mount a camera that views the rear parking area. At the end of the installation, Advanced Security to focus cameras and train the customer.
