A RESOLUTION EXPRESSING SUPPORT FOR  
THE MIDDLETOWN DAYS PARADE AND EVENTS; AND  
TEMPORARILY AUTHORIZING A ROAD CLOSURE, PROHIBITING PARKING  
AND AUTHORIZING REMOVAL OF VEHICLES AND  
ORDERING THE DEPARTMENT OF PUBLIC WORKS TO POST SIGNS

WHEREAS, the Middletown Central Park Association has scheduled the Middletown Days Parade and Events to be held from 12:00 p.m. June 19, 2026, through 8:00 p.m. June 21, 2026; and

WHEREAS, a part of this Middletown Community activity includes a Parade being held on June 20, 2026, that requires the closure of a portion of Hwy 29 and Hwy 175;

WHEREAS, it is the understanding of the Board of Supervisors that the California Department of Transportation (Caltrans) has requested confirmation of the Board's support for the Middletown Days Parade and events; and

WHEREAS, Central Park Road, County Road No. 117U, Santa Clara Road, County Road No. 117G, and Wardlaw Street, County Road No. 117A, will provide an adequate and safe route for a detour around said blocked highways; and

WHEREAS, Section 21101, subdivision (e) of the Vehicle Code authorizes this Board to temporarily close a portion of any street where signs are posted giving notice of the closure; and

WHEREAS, Section 22651, subdivision (n) of the Vehicle Code, authorizes this Board to prohibit parking and the removal of vehicles where signs are posted giving notice of the removal.

NOW, THEREFORE, the Board of Supervisors of the County of Lake does hereby find, determine, resolve and order as follows:

1. The Board of Supervisors of the County of Lake does hereby express support for the Middletown Days Parade and Events to be held June 19, 2026 through June 21, 2026.

2. No person shall operate any vehicle except for the explicit and approved use by the organizer for the parade participants in the following locations from 7:00 a.m. through 1:00 p.m. on June 20, 2026:
  - (a) On Young Street, County Road No. 117B from its intersection with the north side of State Highway 29 to its intersection with the south side of Bush Street, County Road No. 117K.
  - (b) On Armstrong Street, County Road No. 117D from its intersection with the north side of State Highway 29 to its intersection with the south side of Bush Street, County Road No. 117K.
  - (c) On Douglas Street, County Road No. 117E from its intersection with the north side of State Highway 29 to its intersection with the south side of Bush Street, County Road No. 117K.
  - (d) On Callayomi Street, County Road No. 117R from its intersection with the north side of State Highway 29 to its intersection with the south side of Bush Street, County Road No. 117K.
  - (e) On Hill Avenue, County Road No. 117S from its intersection with the north side of State Highway 29 to its intersection with the South Side of Bush Street, County Road No. 117K.
  - (f) On Bush Street, County Road No. County Road No. 117K from its intersection with the east side of Young Street, County Road No. 117B to its intersection with the west side of Hill Avenue, County Road No. 117S.
3. No person shall park any vehicle in the following locations from 6:00 a.m. through 3:00 p.m. on June 20, 2026:

- (a) On the Easterly and Westerly side of Central Park Road, County Road No. 117U, from Pine Street, County Road No. 117J to Santa Clara Road, County Road No. 117G.
  - (b) On the Northerly and Southerly side of Santa Clara Road, County Road No. 117G, from State Highway 175, Central Park Road, County Road No. 117U.
  - (c) On the Northerly and Southerly side of Barnes Street, County Road No. 117X, from State Highway 175 to Wardlaw Street, County Road No. 117A.
  - (d) On the Easterly and Westerly side of Wardlaw Street, County Road No. 117A, from Barnes Street, County Road No. 117X to State Highway 29.
4. No person shall park any vehicle in the following locations from 12:00 noon on June 19, 2026, through 8:00 p.m. on June 21, 2026:
- (a) On the easterly and Westerly side of Santa Clara Road, County Road No. 117G, from Central Park Road, County Road No. 117U.
  - (b) On the northerly and southerly side of Central Park Road, County Road No. 117U, from Pine Street, County Road No. 117J to Santa Clara Road, County Road No. 117G.
5. All vehicles parked in violation of this Resolution may be removed as provided by law.
6. The Department of Public Works shall post signs giving notice of the removal as provided in Section 22651, subdivision (n), of the Vehicle Code.
