

**CALIFORNIA MENTAL HEALTH SERVICES AUTHORITY
 PARTICIPATION AGREEMENT AMENDMENT #3
 Remote Supervision Program**

This Agreement Amendment (“Amendment”) amends Agreement No. 3600-WORK-2023-LC (“Agreement”), a contract by and between the California Mental Health Service Authority (“CalMHSA”) and Lake County (“Participant”) to update the rates listed under the Remote Supervision Program (“Program”). This Amendment shall be effective upon execution by both parties.

This Agreement is hereby amended to adjust the Program’s service rates as noted in Exhibit B – General Terms and Conditions, Item V. Fiscal Provisions, Section B. Rates for Service:
