RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE
AUTHORIZING STANDARD AGREEMENT NO. 25-50257 BETWEEN THE COUNTY OF
LAKE AND THE CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES AND
AUTHORIZING THE BEHAVIORAL HEALTH DIRECTOR TO SIGN THE AGREEMENT

RECITALS

WHEREAS, on June 4, 2024, the Lake County Board of Supervisors adopted Resolution No. 2024-54 authorizing participation in the Behavioral Health Mobile Crisis and Non-Crisis Services Grant Program administered through the California Department of Health Care Services (DHCS); and

WHEREAS, through the Behavioral Health Continuum Infrastructure Program (BHCIP) Mobile Crisis grant, the County received funding to support mobile behavioral health crisis services, including the purchase of four (4) vehicles to be used for mobile crisis response and behavioral health service delivery; and

WHEREAS, the County utilized grant funds to purchase four (4) vehicles, which are currently in use to support behavioral health programs and services within Lake County; and

WHEREAS, although the original grant funding period ended on June 30, 2025, the vehicles purchased under the grant are considered state-owned assets and remain subject to DHCS oversight, compliance, reporting, and asset tracking requirements; and

WHEREAS, DHCS has issued Standard Agreement No. 25-50257 as a post-grant compliance and asset management agreement to formalize the County's continued use of these vehicles for their intended behavioral health purposes; and

WHEREAS, Standard Agreement No. 25-50257 establishes a required six (6) year use period, confirms DHCS retains ownership of the vehicles, and outlines requirements related to allowable use, maintenance, insurance, reporting, and eventual disposition of the assets; and

WHEREAS, Standard Agreement No. 25-50257 is a zero-cost agreement that does not provide additional funding, but instead formalizes ongoing compliance obligations associated with the previously approved BHCIP Mobile Crisis grant-funded vehicles; and

WHEREAS, approval of this agreement will allow the County to remain in compliance with DHCS requirements related to the continued use and management of BHCIP-funded mobile crisis vehicles.

WHEREAS, approval of this agreement will allow the County of Lake to continue participating in and administering state and federally funded behavioral health programs in compliance with DHCS requirements.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Lake hereby approves Standard Agreement No. 25-50257 between the County of Lake and the California Department of Health Care Services and authorizes the Behavioral Health Director to execute the agreement, the Contractor Certification Clauses, and any non-substantive amendments or administrative documents required by DHCS related to implementation and ongoing compliance.
