A RESOLUTION AMENDING RESOLUTION NO. 2024-99 TO AMEND THE ADOPTED BUDGET FOR FY 2024-25 BY CREATING REVENUES AND APPROPRIATIONS IN BUDGET UNIT 1785-PUBLIC SAFETY FACILITIES

WHEREAS, Government Code Section 29130 provides that anticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting; and

WHEREAS, on September 8, 2022, the Lake County Board of Supervisors approved the exchange agreement with the State of California, swapping the former County of Lake property located at 15837 18th Avenue, Clearlake, for the former California Army National Guard Armory, located at 1431 Hoyt Avenue, Lakeport; and

WHEREAS, on July 16, 2024, your board approved the Fund Balance, General Reserve, and Debt Management Policy and the Debt Advisory Committee Policy which these funds will be repaid in accordance to; and

WHEREAS, the Sheriff's Department does not have enough space in their current facility; and

WHEREAS, the County has completed designs to fully renovate the Armory as the Lake County Sheriff Administration Facility to support the 126-member Sheriff Department, including space for administrative offices, investigations, patrol, evidence storage, fitness and training areas, briefing and meeting rooms, and area for future growth; and

WHEREAS, the estimated cost to construct the facility, including engineering and architectural design, construction, construction management, furnishings, equipment, and other related costs is \$20,000,000; and

WHEREAS, on December 3, 2024, your board approved the County of Lake to seek debt financing for the project; and

WHEREAS, anticipated monies in the amount of \$20,000,000 will be received from the issuance of a 2024 Lease Revenue Bond for the purpose of renovation on the former Armory as the County's new Sheriff Facility; and

WHEREAS, the County of Lake has a list of projects which can be assisted with the use of remaining funds not utilized by the renovation project; and
