WHEREAS, in Resolution Number 2024-22, adopted February 27, 2024, the California Department of Water Resources delegated the responsibility of establishing the necessary procedures for the administration of the Program to the Lake County Watershed Protection District (District); and

WHEREAS, The District entered into a Cost-share and Assurance Agreement (Project Partnership Agreement) with the State of California;

WHEREAS, the Project procedures established by the District require a resolution certifying the acceptance of awarded funds for the Project Partnership Agreement; and

WHEREAS, the District has requested an increase in Project funds.

NOW, THEREFORE, BE IT RESOLVED

- 1. That the District is hereby authorized to negotiate with the California Department of Water Resources and enter into a Funding Agreement Amendment for the project; and
- 2. That the Water Resources Director is hereby authorized and designated to negotiate on behalf of the District with the California Department of Water Resources.
- 3. That the Water Resources Director is hereby authorized and designated to sign the Funding Agreement Amendment for and on behalf of the District; and
- 4. That the Water Resources Director is hereby authorized and designated to represent the District in carrying out the District's responsibilities under the Project Partnership Agreement, including approving and signing invoices and requests for reimbursement of Project costs as amended; and
- 5. That all actions, whether previously or subsequently taken by the District, which are consistent with the intent and purpose of the foregoing resolution, shall be, and hereby are, in all respects, ratified, approved, and confirmed.
