That certain roadway, approximately 0.30 miles in length, beginning at its intersection with Snow Road in the Southeast quarter of the Northwest quarter of Section 30, Township 12 North, Range 6 West, M.D.M., said intersection being approximately 0.30 miles Westerly of the intersection of Little High Valley Road and Spruce Grove Road and running in a general Southerly direction to its terminus in Section 30 of Township 12 North, Range 6 West, M.D.M, and to be named Sgt Giffy Road.
- 2. Tuesday, <u>February 6, 2024</u>, at <u>9:25 AM</u> is fixed as the time, and the Board of Supervisors Chambers in the County Courthouse, Lakeport, California, is hereby fixed as the place for hearing all persons interested in the proposed road naming.
