## RESOLUTION AMENDING RESOLUTION NO. 2021-123 ESTABLISHING SALARIES AND BENEFITS FOR EMPLOYEES ASSIGNED TO THE CONFIDENTIAL UNIT, SECTION B, FOR OCTOBER 21, 2021 TO JUNE 30, 2025

WHEREAS, the Board of Supervisors of the County of Lake, State of California, has approved Resolution No. 2021-123 establishing salaries and benefits for Confidential B employees; and

- 6. Day after Thanksgiving Day
