

Amendment No.3 to the Agreement with Marsh EMS Consulting to Provide Professional Services for Med-Health Preparedness Response EMS

This Amendment No. 3 to the Agreement is made and entered into this 1st day of July 2022, by and between the COUNTY OF LAKE, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Marsh EMS Consulting (hereinafter referred to as "CONTRACTOR").

RECITALS

WHEREAS, The parties hereto have entered into an Agreement dated January 3, 2022 under which CONTRACTOR will provide professional consultation services relating to MHOAC Coordination, Med-Health Preparedness Response EMS; and

WHEREAS, The Agreement was amended on March 7, 2022, to extend the term, and maximum compensation of the original agreement; and

WHEREAS, The Agreement was further amended on April 19, 2022, to extend the term, raise the maximum compensation, and amend the Scope of Services; and

WHEREAS, The parties wish to amend the agreement again to further extend the term, raise the maximum compensation proportionally, raise the hourly compensation, and amend the Scope of Services, to allow for additional services described herein.

NOW, THEREFORE, the parties hereby agree as follows:

A. Section 1 – Term is hereby amended to read:

This Agreement shall commence on January 3, 2022, and shall terminate on October 31, 2022.

B. Exhibit B, Section A – COMPENSATION is amended to read:

The total amount that the County shall be obligated to pay for services rendered shall not exceed **ONE HUNDRED FIVE THOUSAND DOLLARS (\$105,000)** over the term of the Agreement.

Exhibit B Section B – HOURLY RATE is amended to read:

C. Exhibit A- Scope of Work is amended to include:

- Provide MHOAC advisory and support to the Health Services Department emergency preparedness program, and planning recommendations
- MHOAC advisor and support to County of Lake Health Services Department relating to emergency medical response required during disasters
- Provide disaster/department operations center training for applicable Health services staff
- Provide response and support of department medical health operations during a declared disaster or in County emergency at the direction of Health Services Director

- Assist department staff with incident action planning and documentation during preplanned events or no notice events.
- Ambulance strike team leader/task force leader for responses in the state of California at the endorsement of Lake County, and direction of Health Services Director
- Provide "Just in Time" disaster specific trainings to Health services staff in response to COVID mitigation, medical health exercises/events, wildfire disaster response and EOC/DOC activation.
- At the direction of the Health Services Director, assist the department Hospital Preparedness Program, a sub-program of the Emergency Preparedness Program by providing recommendations for grant deliverable documentation, and planning recommendations regarding healthcare partner preparedness.

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
