RESOLUTION GRANTING AUTHORITY TO WAIVE TRANSIENT OCCUPANCY TAX INTEREST & PENALTIES ON APPEAL BY AN OPERATOR

WHEREAS, Section 7280 of the Revenue and Taxation Code permits a county to levy a tax on the privilege of occupancy for lodging establishments within the unincorporated areas of the county; and

WHEREAS, the Uniform Transient Occupancy Tax Article of the County of Lake Code was adopted in 1965 implementing said tax; and

WHEREAS, mandatory penalties and interest are assessed on any delinquent taxes imposed by this article pursuant to Section 18-17; and

WHEREAS, the Tax Collector does not have the authority to waive penalties and interest when making a final determination of taxes due, pursuant to Section 18-18; and

WHEREAS, new enforcement efforts resulted in lodging operators, following said final determination by the Tax Collector, filing appeals to the Board of Supervisors pursuant to Section 18-19; and

WHEREAS, on August 20, 2019, the Board of Supervisors passed Resolution No. 2019-118, authorizing the waiver of penalties and interest for first-time operators.

NOW, THEREFORE BE IT RESOLVED, that:

- 1. Pursuant to Section 18-18.6, the Tax Collector holds a hearing where the operator may appear and offer evidence. Authority would be granted to the Tax Collector to consider waivers of interest and penalties for first-time operators at said hearing.
- 2. Any waiver of penalties and interest provided would be contingent upon receipt of payment in full, or strict compliance with the terms of a payment plan.
- 3. The operator must, no later than June 13, 2025, complete their registration and file any missing tax returns to be eligible for a waiver.
- 4. If a successful resolution cannot be reached, the appeal would proceed to a hearing before the Board of Supervisors per Section 18-19.
- 5. This resolution supersedes Resolution 2019-118.
