

BOARD OF SUPERVISORS, COUNTY OF LAKE, STATE OF CALIFORNIA**RESOLUTION NO. _____****RESOLUTION SETTING RATE OF PAY FOR ELECTION WORKERS FOR THE
NOVEMBER 4, 2025, STATEWIDE SPECIAL ELECTION
PURSUANT TO SECTION 12310 OF THE ELECTIONS CODE**

WHEREAS, the Statewide Special Election is scheduled to be held on November 4, 2025, and the Registrar of Voters is charged with the duty to appoint individuals to serve in various positions in order to conduct the election; and,

WHEREAS, beginning 29 days before Election Day through certification (E+30), Election Support Workers may be called to serve in the Registrar of Voters office; and,

NOW, THEREFORE, BE IT RESOLVED that pursuant to California Elections Code section 12310 the Board of Supervisors of the County of Lake, State of California hereby adopts the following rates of compensation for precinct board members and election support workers to be effective October 6, 2025, as follows:

Training Classes

Inspector Training Class (mandatory)	\$50
All other classes (mandatory for first time workers)	\$40
Voting Unit Tech (pickup supplies only)	\$20

Precinct Board Members¹

Inspectors	\$260
Inspector/Techs	\$290
Judges	\$220
Clerks	\$200
VBM Clerks & ADA Voting Unit Techs	\$180
Return of Supplies Election Night (two assigned precinct board members)	\$17 an hour and mileage (Mileage includes from the polling place to the Elections Office and back to the polling place pursuant to the current mileage rate set by the Lake County Travel Policy).

Election Support Workers

Roving Inspectors	\$230 for full day of service
Examining Board Members	\$17 an hour
Drop Box Ballot Couriers	\$17 an hour and mileage (Mileage includes from the Elections Office to the official drop box and back to the Elections Office pursuant to the current mileage rate set by the Lake County Travel Policy).

¹The rate of pay may be adjusted for a half day of service at the Registrar of Voter's discretion.
