

**CALIFORNIA MENTAL HEALTH SERVICES AUTHORITY
 PARTICIPATION AGREEMENT AMENDMENT NO. 4
 Remote Supervision Program**

This Participation Agreement Amendment No. 4 (“Amendment No. 4”) amends Agreement No. 3600-WORK-2023-LC (“Agreement”) and subsequent Amendments (“Amendment”), a contract by and between the California Mental Health Service Authority (“CalMHSA”) and Lake County (“Participant”) to update the rates listed under the Remote Supervision Program (“Program”). This Amendment No. 4 is effective upon execution.

This Agreement is hereby amended to adjust the Program’s service rates beginning from February 2, 2025 as noted in Exhibit B – General Terms and Conditions, Section V. Fiscal Provisions, Item B. Rates for Services to reflect the addition of CalMHSA’s 15% administrative fee.
