

**Amendment No. 2 to the AGREEMENT BETWEEN COUNTY OF LAKE AND CRISIS
SUPPORT SERVICES OF ALAMEDA COUNTY FOR AFTER HOURS CRISIS
SUPPORT SERVICES FOR FISCAL YEAR 2023-24**

This Amendment No. 2 to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Crisis Support Services of Alameda County hereinafter referred to as “Contractor,” collectively referred to as the “parties.”

RECITALS

WHEREAS, the County entered into an Agreement with Contractor effective July 1, 2023, and;

WHEREAS, utilization of services provided by Contractor exceeded projections, and;

WHEREAS, the parties amended the Agreement to increase the total compensation payable under the Agreement by \$1,200 for a new contract maximum of \$89,400.00 on March 27th, 2024.

WHEREAS, the parties now desire to amend the Agreement a second time to increase the total compensation payable under the Agreement by \$800 for a new contract maximum of \$90,200.00 and must amend item three, “Compensation,” to reflect this change.

NOW THEREFORE, based on the foregoing recitals, the parties hereto agree as follows:

Section 3, “COMPENSATION” is hereby amended to state the following:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, “**Scope of Services.**” **Compensation to the Contractor shall not exceed Ninety Thousand and Two Hundred Dollars (\$90,200.00).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled, “**Fiscal Provisions,**” attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.

Exhibit B, Section 4.1, “PAYMENT TERMS” is hereby amended to state the following:

4.1 Contractor shall be compensated by County for the Crisis Support services provided to Lake County residents payable in 12 monthly installments not to exceed \$7,516.76 per month upon a submission of a monthly invoice.
