

AMENDMENT TWO TO AGREEMENT FOR ABATEMENT SERVICES

THIS AMENDMENT TWO TO AGREEMENT FOR ABATEMENT SERVICES ("Amendment Two to Agreement") is made this ____ day of _____ 2025, by and between the County of Lake, hereinafter referred to as "COUNTY" and 360 Junk Removal & Hauling, hereinafter referred to as "CONTRACTOR".

WITNESSETH

WHEREAS, COUNTY and CONTRACTOR have entered into an AGREEMENT effective July 1, 2024, to provide professional property clean up services for public nuisance abatements in the unincorporated area of Lake County; and

WHEREAS, COUNTY and CONTRACTOR have entered into an Agreement for Abatement Service ("Agreement") effective July 1, 2024, to set the per annum compensation amount to not exceed One Hundred-thousand dollars (\$100,000) per year; and

WHEREAS, COUNTY and CONTRACTOR have entered into Agreement Amendment One to amend total compensation to not exceed One Hundred Fifty-Thousand Dollars (\$150,000); and

WHEREAS, COUNTY and CONTRACTOR now desire to amend said Agreement to amend the total compensation limit, not to exceed Two Hundred Fifty-Thousand Dollars (\$250,000); and

NOW, THEREFORE, the parties hereto agree as follows:

Section 3, "COMPENSATION" IS HEREBY AMENDED TO READ AS FOLLOWS:

3. COMPENSATION. CONTRACTOR has been selected by COUNTY to provide the services described hereunder in Exhibit "B" (Scope of Services), attached hereto. Compensation to CONTRACTOR shall not exceed Two Hundred Fifty-Thousand Dollars (\$250,000).

The COUNTY shall compensate CONTRACTOR for the services rendered, in accordance with the provisions set fourth in Exhibit "C" (Fiscal Provisions), attached hereto, provided that CONTRACTOR is not in default under any provisions of this Agreement. Compensation to CONTRACTOR is contingent upon appropriation of federal, state, and county funds.

Except as specifically modified herein, all other terms and conditions of AGREEMENT date July 1, 2024, shall remain in full force and effect.

COUNTY and CONTRACTOR has executed this Amendment Two to Agreement on the day and year first written above.
