19	replacement/upgrade to Lake County's voting system and election management

21	Amendment No 1 which was approved by Resolution No. 2020-01; and

23	WHEREAS, Agreement No. 18G30117 was set to expire on June 30,
24	2022; and Lake County adopted Resolution No. 2022-32 approving the
25	extension of the term of the contract which is set to expire on December 31,
26	2024; and

28	WHEREAS, the Secretary of State's Office is extending the term of the
29	contract to expire on August 31, 2026; and
