RESOLUTION NO. 2024-65

RESOLUTION DECLARING INTENT TO NAME A CERTAIN EXISTING UNNAMED ROAD IN THE COUNTY OF LAKE (GLIDERPORT ROAD)

WHEREAS a petition has been received to name an unnamed road located in the Middletown area of the County of Lake, State of California; and

WHEREAS it is appropriate to set a date and time for the public hearing on this proposal for the Board of Supervisors to consider if it is in the best interest of the County of Lake to name said road;

NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE, STATE OF CALIFORNIA, THAT IT FINDS, DETERMINES, ORDERS AND HEREBY DECLARES THAT:

1. Pursuant to the authority of the Master Grid Numbering System of the County of Lake, it is the intention of this Board to name that certain existing road in the County of Lake as follows:

1.) That certain roadway, approximately 1.0 mile in length, beginning at its intersection with Grange Road lying within the Guenoc Rancho, said intersection being approximately 0.75 miles Southeasterly of the intersection at Grange Road and State Highway 29 and running in a general Southwesterly direction to its terminus within Assessor Parcel Number 014-280-18 also known as the Brambles Golf Course Development and to be named Gliderport Road.

2. Tuesday, 16th, day of July 2024, at 9:20A.M. is fixed as the time, and the Board of Supervisors Chambers in the County Courthouse, Lakeport, California, is hereby fixed as the place for hearing all persons interested in the proposed road naming.

3. The Clerk of the Board of Supervisors is hereby directed to give notice thereof pursuant to the noticing provisions only of Section 970.5 of the Streets and Highways Code of the State of California. The road to be named is not considered a County Highway.
