A RESOLUTION AUTHORIZING THE SUBMISSION OF PLANNING/CONSTRUCTION GRANT APPLICATIONS TO THE STATE WATER RESOURCES CONTROL BOARD (SWRCB) TO DETERMINE THE FEASIBILITY TO CONSOLIDATE SMALL WASTEWATER SYSTEMS, COUNTY SANITATION DISTRICTS (LACOSANS)

WHEREAS, the State Water Resources Control Board (SWRCB) Clean Water State Revolving Fund (CWSRF) Program and Complimentary Program's Intended Use Plan (IUP) outlines small wastewater and septic to sewer consolidation funding incentives, the SWRCB Department of Financial Assistance (DFA) require funding applicants to evaluate the feasibility of the consolidation to be eligible for Clean Water State Revolving Funds (CWSRF). If deemed feasible, consolidation of sewer system projects will be prioritized and eligible for 100% grant/principal forgiveness funding; and

WHEREAS, by the Board of Supervisors, County of Lake, State of California that the Lake County Special Districts Administrator, (the "Authorized Representative") or designee is hereby authorized and directed to sign, file, for and on behalf of the Entity, a Financial Assistance Application for a financing agreement from the SWRCB for the planning, design, and construction of Kelseyville Wastewater System Consolidation/Septic to Sewer Project (the Project"); and

NOW, THEREFORE, BE IT RESOLVED This Authorized Representative, or his/her designee, is designated to provide the assurances, certifications, and commitments required for the financial assistance application, including executing a financial assistance agreement from the State Water Resources Control Board and any amendments or changes thereto.

BE IT FURTHER RESOLVED, The Authorized Representative, or his/her designee, is designated to represent the Entity in carrying out the Entity's responsibilities under the financing agreement, including certifying disbursement requests on behalf of the Entity and compliance with applicable state and federal laws.
