This Amendment No. 2 to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Crestwood Behavioral Health, hereinafter referred to as "Contractor," collectively referred to as the "parties."

RECITALS

WHEREAS, the County entered into an Agreement with Contractor effective July 1, 2022, and;
