

**Amendment No. 2 to the AGREEMENT BETWEEN COUNTY OF LAKE  
AND CRESTWOOD BEHAVIORAL HEALTH FOR ADULT  
RESIDENTIAL SUPPORT SERVICES AND SPECIALTY MENTAL  
HEALTH SERVICES FOR FISCAL YEARS 2022-23, 2023-24, and 2024-25**

**This Amendment No. 2 to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Crestwood Behavioral Health, hereinafter referred to as “Contractor,” collectively referred to as the “parties.”**

**RECITALS**

**WHEREAS**, the County entered into an Agreement with Contractor effective July 1, 2022, and;

**WHEREAS**, utilization of services provided by Contractor exceeded projections, and;

**WHEREAS**, the parties now desire to amend the Agreement to reflect a change in rates and must amend Exhibit B, item 4, “Payment Terms,” to reflect this change.

**NOW THEREFORE**, based on the foregoing recitals, the parties hereto agree as follows:

**Exhibit B- Fiscal Provisions, Section 4, is hereby amended as follows:**

**4. PAYMENT TERMS.** County shall reimburse Contractor for services provided to Lake County Medi-Cal beneficiaries per the schedule below:

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
