## **RECITALS**

**WHEREAS**, Sections 29125, 29126, 29126.1, and 29130 of the Government Code provides authority for the Board of Supervisors to transfer and revise appropriation, cancel unused appropriation, transfer unused appropriation to contingencies, reduce estimate and cancel appropriate designations and reserves other than the general reserve; and,

**WHEREAS**, the Community Development Department Building Division has a deficit fund balance due to lack of permit requests and MOU mandated salary increases; and,

**WHEREAS**, The Community Development Department Building Division has requested a short-term loan from the General Fund in the amount of \$390,000 to be paid back prior to the end of the current fiscal year; and,

**WHEREAS**, the loan will be repaid to the Budget Stabilization Reserve within the current 25-26 fiscal year; and,
