RESOLUTION AMENDING RESOLUTION NO. 2021-122 ESTABLISHING SALARIES AND BENEFITS FOR EMPLOYEES ASSIGNED TO THE CONFIDENTIAL UNIT, SECTION A, FOR OCTOBER 21, 2021 TO JUNE 30, 2025

WHEREAS, the Board of Supervisors of the County of Lake, State of California, has approved Resolution No. 2021-122 establishing salaries and benefits for Confidential A employees; and

WHEREAS, the Board of Supervisors subsequently approved Resolution No. 2021-122 including the description of the maximum monthly county contribution for insurance coverage; and

WHEREAS, The Board now desires to increase the maximum monthly county contribution for insurance coverage to one thousand five hundred dollars (\$1,500.00).

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lake, State of California, that Resolution No. 2021-122 is hereby amended as follows:

1. Effective July 1, 2023 Section 3, "HEALTH AND LIFE INSURANCE" is hereby amended as follows:

HEALTH AND LIFE INSURANCE

Maximum Monthly County Contribution for Insurance Coverage 3.1

The COUNTY shall pay a maximum contribution of one thousand five hundred dollars (\$1,500.00) per month toward the COUNTY-sponsored group medical, dental and vision insurance plan for each employee who enrolls in such a COUNTY sponsored group medical, dental and vision insurance plan.

Under the COUNTY's flexible benefits plan, a specific amount (as defined in Section 22892 of the California Government Code, which is adjusted annually based on inflation) of this contribution is specifically designated for group

medical insurance, with the balance of the COUNTY contribution available and paid toward an employee's total group medical, dental, and vision premium.

In no event shall the COUNTY's financial obligation exceed the actual monthly premium for an employee's medical, dental and vision insurance choices under the County's flexible benefits plan. Employees who select such employee-only coverage and/or employee plus one dependent coverage with total monthly premiums less than one thousand five hundred dollars (\$1,500.00) per month will not be entitled to receive in cash, other compensation, benefits or in any form the difference between the amount of the cost of such coverage and the one thousand five hundred dollars (\$1,500.00) per month COUNTY contribution.

- 2. All prior amendments to the description of HEALTH AND LIFE INSURANCE Section 3.1 Maximum Monthly County Contribution for Insurance Coverage of Resolution No.2021-122 are hereby superseded.
- 3. Except as specifically modified herein, all other provisions of Resolution No.2021-122 shall remain in full force and effect.
